#### **Election 2024**

Following the November 5, 2024 election, all national and Pennsylvania races have now been called.

#### **Presidential**

Donald J. Trump won Pennsylvania with 50.37% of the popular vote. On December 10, 2024, Governor Josh Shapiro and Secretary of the Commonwealth, Al Schmidt certified the 2024 Presidential election results, and Shapiro signed the legally required Certificate of Ascertainment for Pennsylvania. The Republican electors met in the House of Representatives Chamber on December 17, 2024 to cast their ballots for Pennsylvania's 19 electoral college votes.

#### Congress

**Senate**: Dave McCormick (Rep) won the six-year-term U.S. Senate seat with 48.82% of the vote over incumbent Robert P. Casey, Jr. (Dem). The Senate will be 53 Republicans to 47 Democrats.

**House**: Pennsylvania's 17-person U.S. House delegation saw a two seat gain for Republicans (10) for a 220 (R) to 215 (D) total. Terms are two years.

#### **Pennsylvania Statewide Offices**

Attorney General: Dave Sunday (Rep) with 50.81% of the vote (incumbent did not run)

Auditor General: Tim Defoor (Rep) (incumbent) with 51.13% of the vote

Treasurer: Stacy Garrity (Rep) (incumbent) with 51.91% of the vote

#### The Pennsylvania General Assembly

The 2023-2024 legislative session has ended, also known as sine die, and members will be sworn in on January 7, 2025, for the 2025-2026 session. Both parties held their leadership elections in November before adjourning. Since the elections, Majority Whip Senator Ryan Aument (R-36) announced his intent to resign to take a position with U.S. Senatorelect Dave McCormick. Upon his official resignation, Lt. Governor Austin Davis has ten days to call for a special election to fill Aument's seat, which must take place no sooner than 60 days from the date the seat was vacated.

PA Senate: The four-year-term oddnumbered Senate seats (25) were up for election this year. The Senate remains at 28 Republicans to 22 Democrats, with four new members.

**PA House:** All of the two-year-term 203 House seats were up for election this year. The House remains at 102 Democrats to 101 Republicans, with five new members.
